## Explorer Fire Games Terms of Use

Due to the nature of the activities and programs made available to the public by the City of Rowlett's Fire Department, there is an inherent risk of injury. (In this agreement, "City" means the City of Rowlett, Texas, and the Rowlett Fire Department, their officials, officers, employees, and representatives.) Participation in Fire Department Training activities, Explorer Games, City programs, and use of the buildings, rooms, facilities and/or equipment of the City is a privilege and license given by the City, not a right granted, and may be revoked at any time for any or no reason. In consideration for and conditioned on the following terms. By participating in programs and activities or using equipment or facilities, you agree to all of the following conditions:

You, the participant, acknowledge the existence of risks in connection with the programs, activities, facilities and equipment, and assume and agree to accept all responsibility for any personal injury, death and property damage and loss to you and your dependents and guests and for any injuries and/or damage to the facilities or equipment, including but not limited to that which in any way arises from 1) participation in supervised and unsupervised activities available at the City, and in individual or group exercise activities; 2) accidents which occur during activities and within City facilities; and 3) any and all activities located and/or not located at the facility but which are sponsored in whole or part by the City.

In addition to your acceptance of all responsibility, you, the participant, release, discharge, waive, indemnify, defend and hold harmless the City and its employees, representatives and personnel from and against all claims, demands, suits, liabilities, personal injury or death to any person, property damage, economic loss, and any loss of any kind, including all expenses of litigation, court costs and attorney's fees, arising directly or indirectly from participation in any program or activity and use of City facilities and equipment. This release, discharge, waiver, indemnification and hold harmless commitment is on your behalf as well as that of your child(ren) and guests, and includes injuries, death, or loss caused by the City's sole negligence or the joint or concurring negligence or fault of the City and any other person or entity, including you, members of your family, or your guests.

You further agree to read and to abide by the rules presently existing and any future amendments to the rules and regulations relating to City facilities and equipment. A failure to abide by the rules or display of offensive or disorderly behavior may result in ejection from any City facility and/or suspension or termination of participation and membership privileges. You may be held responsible for damage to the facility, supplies, or equipment caused by you, your dependents and your guests. You agree to follow all rules set forth by the City regarding children's usage of the facility, accept full responsibility for their safety and any damage caused by them, and agree to maintain proper control and discipline over them.

You also grant and give the City the right to use your or your child's photograph or image with or without names both alone and in conjunction with other persons or objects for any and all purposes including private or public presentations, advertising, publicity and promotions.

You also authorize the City to administer first aid (to include CPR) to you or your dependents and to take whatever action may be necessary in emergency medical situations. You agree and intend that the terms of this release and indemnification agreement extends to the provision or non-provision of such first aid. You agree that you will be financially responsible for paying the charges for any such treatment.
